Board of Directors Meeting  
August 8, 2013  
Minutes

**1. Call to Order.**

President Roger Baldwin called the meeting to order at 7:05 PM in the Floriston School House.

**2. Introductions and quorum determination.**

President Roger Baldwin, Secretary Peter Fike, Treasurer Debbie Grooms and Commissioner of Water and Roads Chuck Grooms were present. A quorum was established. Manager Rick Gardner was also present.

**3. Approval of Minutes.**

Chuck Grooms moved to approve the minutes of the June 27, 2013 Board meeting. Debbie Grooms seconded the motion, which passed unanimously.

**4. Members' Forum.**

Mr. Bailey also asked what the bulletin board was for and was told that a discussion regarding the bulletin board was scheduled later in the meeting.

Win Crowell stated that the Brown Open Meeting Act requires Boards to meet in a neutral place. Rick Gardner answered him by saying that even if the Brown Open Meeting Act did say that, Associations are not subject to the Brown Open Meeting Act because associations are not governmental agencies.

Scott Pomin asked questions regarding the grant and asked what percentage of the membership is required to ask for a special meeting.
